

#### Premises, Health and Safety

Please take action on the following:

- **Online Safeguarding** Research show the importance of developing online resilience and providing a safe and trusted space for children to disclose information. There are many things online which are 'legal but harmful'. For example, the news on war or climate change is legal but potentially upsetting. We may not be able to block all harmful content (especially outside of schools) but we can offer a listening ear and support.
- **Earrings** In response to questions safety concerns about earrings, the trust has produce an information sheet which has been circulated to all staff as well as model '*Dear Parent*...' letters. Key points are:
  - $\circ$   $\;$  No jewellery is worn for PE by the child including earrings.
  - Covering earrings with micropore tape or plasters is not sufficient.
  - Staff should not accept a disclaimer from a parent giving permission for earrings to be worn or covered up by tape or plasters.
  - Staff are not permitted to remove or insert earrings and cannot accept responsibility for the safe keeping of such items.

The trust takes a firm line on this subject because teachers could be legally liable for any injuries if they don't follow the above advice. If a child cannot take part in PE because of earrings, they should not be excluded from the lesson. They could be involved in planning, coaching, umpiring, recording etc.

#### And finally...

The first week of November is National Trustees Week. We have an excellent board of trustees who really care about great education for our children. They are all very busy people but their commitment and dedication to our children, staff and trust is highly commendable. They have frequent meetings, attended INSET days and are regulary in touch with the core team on top of mountains of paperwork! Their expertise, advice and support are much appreciated!
